Under each extract or summary, the judgements and orders are referred to by case number in ascending order. The articles of the EC Treaty are cited according to the method of citation pursuant to the renumbering of the articles of that treaty brought about by the Treaty of Amsterdam. The book covers all the case law of both courts until March 2008.

With this book practitioners will quickly find relevant paragraphs and full citations regarding all issues raised by Articles 87-89 EC, including the following and much more:

- territorial scope of State aids;
- Article 87(1) EC and WTO agreements;
- conditions for categorizing a national measure as State aid;
- free movement of goods;

- undertakings;
- private vs. public investment;

- aid liable to affect trade and to distort competition;
- the Altmark conditions for public service aid;
- restructuring aids;
- administrative procedure;

- scope, nature, and limits to the Council's power under Article 88(2) EC.

In many areas, the extracts in this book relate to points of the judgements which are not or only partially treated in official summaries.
